1	02-09-2025	On 2nd September at 7:00 AM, our internal team detected suspicious activity, which was promptly escalated to our security partner CrowdStrike and we engaged Crowdsrtike to identify the malicious activity and the note received about Ransomware on some systems.. It was discovered the threat actor encrypted the files, and as a precaution, affected hotels and users were instructed to shut down systems to prevent further spread. The attack was categorised as sophisticated, and a coordinated containment effort was carried out involving IT, OEMs, and vendors.
2	25-09-2025	We were informed that there has been an unusually high number of OTP SMSs generated and this led to us conducting an internal investigation, after which we determined that our Website experienced a malicious code attack in the nature of a bot attack which created multiple SSO requests ("Bot Attack"), thereby inflating SMS charges. However, please note that we have not found any evidence to suggest that the Bot Attack resulted in unauthorized access to any data/IT systems/user accounts or any compromise of data.
